NC Legislative News

Connect NC Bond Act HB943

The State of North Carolina is moving forward with putting a bond measure before the voters at the March 15 State Election for \$2,859,076,952 in general obligation bonds of the State to provide funds to update the State's public facilities for construction, repair, renovation and renovation of highways, roads, bridges and related road infrastructure.

The UNC system would receive \$980 million for new construction and renovation of all UNC campuses statewide.

Community Colleges would receive \$350 million for new construction, repairs and renovations for 58 campuses.

State Agricultural research facilities and Consumer Sciences Lab for veterinary, food, drug and motor fuel testing would receive \$179 million.

The Quality of Life \$409.5 million allocation is split as follows: \$75 million would go to state parks, \$25 million for the zoo, and \$309.5 million for water and sewer infrastructure.

Public Safety is allocated \$79.5 million for 3 National Guard Readiness Centers and a Public Safety Training Academy.
